According to the study of worthy (1986) prosocial behaviour signifies additional exertion and thoroughness at work. Performances such as working on signifying ways to progress and guard the organization, or speaking constructively about the organization to interlopers are prosocial organizational behaviour which endorse and increase the proficiency of the organization.

On the other hand, the behaviours cited above are important for the organizations to persist. Pro-social organisational behaviour which is measured as an inclusive area to talk about will highlight the dysfunctional aspects of the pro-social organizational behaviour in this paper.

Kinds of Prosocial Organizational Behaviours

Organ and Konovsky (1989), however, appealed that prosocial behaviours reproduce a combination of societal and monetary exchange relationships with the organization.

In response to the study of Brief and Motowidlo (1986), pointed out that there are thirteen unambiguous types of prosocial organizational behaviours out of which three have crucial dissimilarities between them. The first one is the aim to which prosocial acts are engaged. The second difference is about some prosocial behaviours are organizationally practical because they subsidize to the achievement of organizational objectives, while the third distinction is amongst prosocial behaviours that are role-prescribed.

Amongst the thirteen kinds of prosocial organizational behaviours which Brief and Motowidlo (1986)identified, only limited of them are extremely desirable. Furthermore, when Staw(1984) endorsed that prosocial behaviours need not be constrained to doings towards individuals but can also contain actions toward the organization as a unit, Brief and Motowidlo (1986) revealed that prosocial performances directed towards individuals are not essentially in the finest welfares of the organization.

On the other hand, Brief and Motowidlo (1986) projected the indulgent of prosocial configurations of gesture in organizations that can lead to developments in organisational strategy and organizational design and at the same time support organizations lead a more effective and content lives. The chief under scoring goal of this research paper is to climax the significant role of prosocial organizational behaviour in the smooth and effective functioning of any organization and improving the quality of life of those directly and indirectly involved in the same.
